Cov kws lij choj pab neeg nkag teb chaws (immigration lawyers) yog ib co kws lij choj uas muaj ntaub ntawv tso cai los leg dej nug txog cov kev cai lij choj uas khoo txog kev nkag teb chaws. Lawv ua hauj lwm pab cov neeg ntiav lawv, thiab muaj cuab kav sawv cev cov neeg ntiav lawv mus hais lus rau tsoom fwv cov chaw ua hauj lwm pab neeg nkag teb chaws, xws li tsev hais plaub rau cov neeg nkag teb chaws, thiab pab ua ntaub ntawv nkag teb chaws thiab thov kev pab cuam. Tus kws lij choj ntawd muaj cuab kav yuav muab kev sab laj txog kev cai lij choj thiab qhia koj seb hom kev nkag teb chaws zoo li cas thiaj pab tau koj.
